## Liability/Release for Participation in RAC Ballet Lessons

1. I have the authority to release the claims and have not assigned or transferred any claims to any other party. The provisions of this release are severable. If any provision is held to be invalid or unenforceable, it shall not affect the validity or enforceability of any other provision. This release constitutes the entire agreement between the parties and supersedes any prior oral or written agreements or understandings between the parties concerning the subject matter of this release. This release may not be altered, amended, or modified, except by a written document signed by both parties. The terms of this release shall be governed by and construed in accordance with the laws of the State of Texas.
